 - **Student Learning Outcomes:** This course aims at introducing the students to modern computer networks, in particular the Internet. We will discuss basic network architecture, design principles, different protocols, and applications. We will study the application, transport, networking, and link layers. We will also cover basic topics of network security and management. Students are expected to perform various projects, including network programming, to obtain hands on knowledge.

Course Content: We will cover the first 5 chapters of the textbook and partially Chapters 6 and 8.

Grading policy: There will be mid-term and final exams. There will also be 4 quizzes during the semester, which will be announced at least one week ahead (NOT popup). Among the 4 quizzes, the one with the lowest point for a student will NOT be counted toward his/her final score.

Projects and Programming : Projects in this course will be performed in diverse environments, including working with existing network simulators, interacting with product network environment, and direct programming in networking devices. Java is the preferred languages for project assignments.

Attendance: At The University of Texas at Arlington, taking attendance is not required. Quiz and Exam Makeup: There will be no exam or quiz makeup. Missed exam/quiz will result in zero mark.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
